Madam,

I would like to draw your kind and immediate attention regarding the following issue for their early settlement.

It is observed in Area (Planning) after implementation of the above order that, the gross pay for the month of April 09 of executives appointed after 01-01-2007 and occupying departmental quarter is less as compared to the gross pay of the previous month March-09. Further in the letter No. 1-11/2009-PAT (BSNL) dated 31-03-09, there is no clarification regarding difference in pay scale within executives of the same batch, i.e. 2005 direct recruited JTOs.
